### **Expression of Interest for Information regarding Disposal off of unused Microwave towers installed in GAIL**

#### **1.0 Introduction:**

GAILTEL, the Telecom & Telemetry services arm of GAIL (India) Limited, is providing communication services for its business critical pipeline Supervisory Control and Data Acquisition (SCADA), Enterprise Resource Planning (ERP) for automation of organization-wide business processes/functions and inter/intra office communications apart from commercially leasing telecom services to telecom operators across India since 2001.

GAILTEL services include long term lease of Dark Fibre and Duct under IRU, Tower space & collocation facilities and point-to-point leased line Bandwidth services. With SDH as the core layer, GAILTEL network is built largely along the highly secured GAIL's cross country pipeline corridor and ensure highly reliable and error free service to its internal & external customers. The network is managed centrally on 24X7 from a state-of-art Network Management Centre at Noida.

GAILTEL, today serves most of the Telecom operators of the country, which include Vodafone, TCL(VSNL), Bharti Airtel, PGCIL, RAILTEL, to name a few.

#### **2.0 Intent of EoI :**

GAIL intends for disposal off Microwave towers which are presently not in use. For disposing off these towers GAIL needs following information from the Participant:

1. The list of certified/authorised vendor for this job
2. The details requirement of types of certificates from authorised vendor issued by statutory authority.
3. Policy & Procedure includes scope of work for the disposal of Tower
4. Analysis report on revenue/expenditure for this job.
5. Safety procedure while execution of the job

### **3.0 Expression of Interest (EoI) :**

GAIL hereby invites applications for Expression of interest from interested parties who wish to provide information for disposal off Microwave towers installed along GAIL pipeline network which are presently not in use. Applicants shall ensure that they meet the Eligibility Criteria as Defined at Para 4.0 and Qualifying requirements as defined in Para 5 below.

The application shall be submitted along with relevant supporting documents in support of meeting Eligibility Criteria. GAIL will consider the applications for suitability in line with the terms and conditions brought out hereunder and shortlist the bidders based on the information provided by them vide this Expression of Interest. GAIL may call the parties who have submitted their Expression of Interest for discussions regarding the terms & conditions for Disposal off of the towers, limitations if any and to comply to the queries of the applicants.

### **4.0 Eligibility Criteria :**

This Invitation for Proposals, issued by the GAIL is open to all firms including company(ies), Government owned Enterprises registered and incorporated in India as per Companies Act, 1956 or 2013

### **5.0 Qualifying Requirements and documents to be submitted along with EoI:**

Qualification of bidder will be based on meeting the qualifying criteria specified below regarding bidder's commercial and technical credibility.

The bidders are required to furnish the following documents (commercial & technical) to assess the capacity and capability of the bidder.

#### **5.1 Commercial**

(i) Certificate of incorporation

(ii) Service tax registration certificate

(iii) Audited balance sheet and profit & loss account for last three financial year starting from 2011-12.

(iv) Copy of PAN

#### **5.2 Technical**

i) The bidder must be a Mobile Network provider/ Telecom operator/ Telecom Consultant/ Telecom Infrastructure Service Provider/ Other Company having own telecom network and possess a valid Telecom License/permission/clearance from the concerned Licensing Authority i.e. Dept of Telecom, Govt. of India for the intended telecom business. Bidder has to submit document in support of the same.

The bidder has to furnish document in support of experience in providing telecom Infrastructure services or having telecom network for its own use.

**6.0** Statutory clearances and approvals like WPC, SACFA, Way Leave, Environment and Forest clearance etc. (if required) shall be taken up by the Service providers at their own risk and cost.

**General information and Scope of Work:** General information and Terms & conditions regarding lease of Microwave towers are enclosed herewith in **Section - II.**

**7.0 Location of Towers/ Package details:** The details of topographic information and tower heights of various towers which are presently not in use have been provided in **Section –III.**

**8.0 Schedule of Activities :**

GAIL invites Expression of Interest from experienced parties for the subject EoI. - 5.0 Bidder shall prepare and submit the procedure includes the scope of work, standard instructions and safety measure for disposal of tower.
- 6.0 Bidder shall provide the list of vendors, eligibility and type of experience criteria's of selection of vendor for the execution of disposal of GAIL tower.**
- 7.0 Bidder shall provide the execution period of the individual tower as well as total project period.**
- 8.0 Bidder shall provide information about any statutory approval or clearance for the disposal of tower.**
