Empanelment of Advocates

1. A panel of advocates is required for District Courts, High Courts, and Arbitration Tribunals etc., for GAIL at Belgaum, Gadag, Dharwad, Bellari, Davangere, Chitra Durga, Tumkur, Mangalore and Bangalore.
2. Panel will be in the following categories:

Category "A"

Advocates with an active practice of 8 – 15 years before Lower Courts are placed in category "A". Fee structure limit for the Advocates of this category is applicable in the metropolitan cities and places having High Court and its Branches.

Category “B”

More than 15 years of effective practice in the High Court including District Courts.

Category “C”

Minimum of 8 to 15 years of effective practice in the Lower and District Courts. (Unclassified areas).

a. Other Conditions:

- i. Advocates having experience in handling Court and Arbitration matters. Preference will be given to the Advocates having worked with the Central PSUs including those under the Ministry of Petroleum and Natural Gas. Reference can also be made of any international assignments including arbitration, legal due diligence etc.
 - ii. Advocates having adequate infrastructure including Office, Computer with e-mail facility, well maintained Law journal library and legal software.
 - iii. Advocates having at least 2 Junior Associates registered at Bar working with him on regular basis.
