The instant EOI shall not be construed as Empanelment Exercise or Tender Terms & Conditions. EOI is being floated to seek suggestions from prospective Bidders for modifications (if, any) of existing terms & conditions of typical Tender Document being floated by GAIL for ILI activities of their pipelines. The objective is to get a feedback from prospective interested ILI Vendor(s) to encourage bidders to participate in the future bidding process.

GAIL (India) Limited is operating a large network of Natural Gas and LPG Pipelines across India. For integrity assessment of pipeline sections, GAIL hires the service of ILI Contractor/Vendor. ILI Contractor(s) is selected by inviting bids from prospective bidders through International Competitive Bidding and finalise the Bid(s) based on certain Technical and Financial Criteria.

On an average, integrity assessment of approximately 1000-1500 kilometre pipelines per year through ILI (MFL Technology) is being done by GAIL.

Interested ILI Contractor/Vendor having requisite works experience is invited to submit necessary documents in support of their credentials in order to get pre-qualified for the proposed enlistment for further structured deliberation.

ILI Vendor participating against the EOI will be shortlisted based on submitted Application Form along with attached documents. Shortlisted ILI Vendor(s) will be invited to participate in the subsequent discussion.

1.0 SCOPE OF WORK:

1.1 BACKGROUND:

GAIL (India) Ltd is a Central Public Sector Undertaking (PSU) under the Ministry of Petroleum & Natural Gas (MoP&NG) Government of India.

GAIL operates network of Natural Gas Pipelines covering more than 11000 Km with a capacity of above 206 MMSCMD & two LPG Pipelines covering 2040 Km with a capacity of 3.8 MTPA of LPG.

1.2 OBJECTIVE:

The typical scope of work under ILI contract includes In-Line Inspection of pipelines by running foam pig, gauge pig, cleaning pigs (Magnetic / Brush), electronic geometry pig (EGP), High resolution MFL technology based Axial MFL & Circumferential MFL pigs with XYZ mapping for pipelines to detect and quantify internal / external metal loss, mechanical anomalies, geometric anomalies, laminations, circumferential and axial cracks / crack-like anomalies, girth & seam weld anomalies, pipe wall thickness and other anomalies & features. Contractor shall also be responsible for all the associated activities, services and material / equipment necessary to complete the work (other than those explicitly specified in the contract to be in the scope of GAIL) and the rates quoted by the contractor shall be deemed to include the same.

To make the tendering process more participative and encouragement of bidders across Globe; interested ILI Vendor is requested to review the tender terms & conditions (the previous Tender Document for ILI jobs is attached for reference) and offer their opinion/suggestions as per the Format given at Annexure-I.
