DESIRED QUALIFICATION:

- i. Medical Council of India or State Medical Council recognised MBBS.
- ii. Training in Industrial Health of minimum three months duration recognised by the State Government / copy of Diploma in Industrial Health or equivalent.

EMOLUMENTS & OTHER BENEFITS:

- i. Consolidated Monthly remuneration of Rs. 93,000/- (Rupees Ninety Three Thousand Only) will be paid per month.
- ii. OPD expenses (as in-house medical facility not available at GAIL, Usar) of Rs.1,000/- per month. This amount shall be paid on monthly basis along with consolidated remuneration.
- iii. Family floater insurance coverage of Rs.5 Lakhs for indoor treatment in respect of self, spouse and two immediate dependents i.e. children and/ or parents.
