■ विस, नई दिल्ली : केंद्र सरकार को साल 2023 में 67 लिस्टेड सार्वजनिक क्षेत्र के उपक्रमों (PSU) से 63,056 करोड़ रुपये का रेकॉर्ड डिविडेंड मिलने की संभावना है। वित्त वर्ष 2022 में इनसे सरकार को 50,583 करोड़ रुपये का डिविडेंड मिला था। यानी इसमें इस साल 24.7% की बढ़ोतरी की उम्मीद है। गेल (इंडिया), हिंदुस्तान कोयला सहित कुछ सार्वजनिक उपक्रमों ने अभी तक डिविडेंड की घोषणा नहीं की है। सरकार ने इस बार RBI सहित दूसरे सरकारी उपक्रमों से ज्यादा डिविडेंड की अपील की थी।
