

## IMPORTANT INSTRUCTIONS BEFORE YOU APPLY ONLINE

**Advt. No.: GAIL/OPEN/LAW/2/2020**

Please go through the detailed advertisement and ensure that you meet all the eligibility requirements and other conditions specified in the detailed advertisement, before you start filling up the application online.

Since all the applications will be screened on the basis of data submitted by the candidate in the online application form, the candidates must satisfy themselves of the suitability for the position to which they are applying. If at any stage during the recruitment and selection process, it is found that the candidates have furnished false or wrong information, their candidature will be rejected. Canvassing in any form during any stage of recruitment process will lead to cancellation of candidature.

Application once submitted cannot be altered / resubmitted, under any circumstances. **Further, no request with respect to making changes in any data/ particulars entered by the candidate in the Online Application form will be entertained, once the application is submitted successfully.**

Please keep the following points in mind while applying online:

- Percentage of marks in the essential qualification(s) shall be considered as per rules/ norms of the concerned Institute/ University. Wherever, CGPA/ OGPA or letter grade in a degree is awarded, equivalent percentage of marks should be indicated in the application as per norms adopted by University/ Institute.
- Experience details along with industry type, period served, position title, pay scales & job responsibilities. In case you have served at different positions in an organization, details of all such positions held in the organization with period served, position title, pay scales & job responsibilities.
- Category [EWS/SC/ ST/ OBC (NCL)/ PwBD] once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
- You must possess a valid e-mail ID for applying online as the same will be used for future correspondence with you. Please create a new e-mail ID, if you do not have one, prior to filling up online application.
- In case, a candidate has previously applied for any post in GAIL , in order to apply for a fresh post, the candidate is required to apply online using a different USER NAME and E-MAIL ID (rest all details can be the same).
- Scanned copy of self-attested recent passport size colour photograph **(3.5 X 4.5 cm)** of the candidate with white background (**.JPEG/ .JPG/ .BMP format** size upto 50 KB).

- Candidates belonging to EWS/SC/ ST/ OBC (NCL)/ PwBD category, will be required to submit relevant caste/tribe certificate/ PWBD certificate in the prescribed format issued by the Competent Authority as prescribed by Government of India, along with the hard copy of the online application form. To download the prescribed format please click relevant link “**Download prescribed format for EWS/SC/ ST/ OBC(NCL)/ PWBD certificate**” available on “careers” section of GAIL website [www.gailonline.com](http://www.gailonline.com)
- Candidates belonging to **General, EWS and OBC (Non Creamy Layer)** category are required to pay a non-refundable application fee of Rs. 200/- (Rupees Two Hundred only)(excluding applicable bank charges) by any one of the following 03 modes:
  1. Net banking of any Nationalised/ Private Banks
  2. Card payments of any Nationalised/ Private Banks
  3. Other Payment Mode: Pre Acknowledgement Payment (PAP) form through State Bank of India Branch.

The application fee is to be paid by logging into website of State Bank of India ([www.onlinesbi.com](http://www.onlinesbi.com)) and further selecting the option “State Bank Collect”. The User Manual for payment of application fees is available at GAIL website ([www.careers.gail.co.in](http://www.careers.gail.co.in)). Further, the details of the SBCollect Reference Number is to be filled up in the online application form. The Application fee once deposited/ paid will not be allowed to be withdrawn and the application fee once paid will neither be refunded on any account nor would this fee be held in reserve for future exam/ selection.

- After successfully submitting online application, you will receive an auto generated e-mail confirming successful submission/ registration of your online application.
- After submitting online application, candidate is required to download the application form generated by the system with unique registration number (Refer User Manual for detailed instructions to download the application form). Candidate should put his/ her signature at the space provided and keep the form with him/ her for future reference.
- **Candidates are NOT required to submit hard copy of application form to GAIL at this stage.**
- The last date for filling online application form is **1800 hrs of 04.12.2020**. However, it is advised to submit your application at the earliest to avoid any last minute rush.
