As per Regulation 23(9) of SEBI LODR Regulations, 2015 - The listed entity is required to submit to the stock exchanges disclosures of related party transactions every six months on the date of publication of its standalone and consolidated financial results. GAIL's Board in its meeting held on Tuesday, 31st October, 2023 approved Unaudited Financial Results (Standalone & Consolidated) of the Company for the quarter and half year ended

30.09.2023. Financial Results were filed on the same day within statutory timeline, however, due to **technical issue in RPT XBRL utility**, Company could not file disclosures of related party transactions on 31st October, 2023. However, the same was successfully filed on 1st November, 2023 (within 24 hours from the conclusion of the Board meeting).

This is to submit that the non-compliance with regard to late submission of disclosures under Regulation 23(9) w.r.t. related party transactions neither due to any negligence/default by the Company but to technical issues faced by the Company on NEAPS portal. Accordingly, request for waiver of fine with NSE has been made by the Company.
