Shri Sanjay Kumar played important role in developing GAIL's overseas LNG trading subsidiary GAIL Global (Singapore) Pte. Ltd. into a standalone entity that is now well established in the global LNG business. In GAIL, Shri Sanjay Kumar was responsible for overseeing GAIL's Gas Marketing and Transmission business.

Presently, he is the Managing Director of Indraprastha Gas Limited (IGL), the largest CNG distribution company of India.

The company is taking necessary action to complete the appointment formalities. Requisite disclosures including his date of assuming charge to the post of Director (Marketing) of the Company will be submitted in due course.
