Ko warehouse fire result of TMC's corruption: Shah

'CM Blinded By Affection For Her Nephew'

Kolkata/Siliguri: Union home minister Amit Shah alleged on Saturday the eastern Kolkata warehouse fire that killed 57 was not an accident but the result of Trinamool Congress's corruption and claimed CM Mamata Banerjee "needs a cataract operation" because she is blinded by affection for her nephew Abhishek Banerjee. Addressing BJP workers in Barrackpore on Kolkata's outskirts, Shah said Trinamool govt failed victims because of corruption and vote-bank politics. He claimed BJP would have reacted differently had "if the victims been infiltrators", adding police beat BJP workers who tried to protest. "She should be ashamed," Shah said. Later, at a public meeting in Siliguri in north Bengal, Shah alleged that Trinamool's men were involved in the blaze that gutted two warehouses — owned by Pushpanjali Decorators and partly leased to pan-India fast-food chain Wow! Mom.



Amit Shah at a rally in Barrackpore Saturday. Questioning TMC's alleged links to the mummy factory operating in the warehouse, he demanded a "proper probe" into the blaze and asked who had invested in the factory. Shah said the warehouses lacked environmental clearance and were built on wetlands. "Had anyone closed the gate when people were shouting inside? After a BJP govt is formed here in April, we will find the culprits and put them behind bars," he said, referring to the assembly elections.

Reeling off names of 23 Trinamool politicians facing corruption allegations, Shah challenged the CM to field them as candidates in the upcoming elections. "She cannot do that because she is afraid they will turn witnesses against bhaiipo," he said. Shah promised that if BJP is elected to office in Bengal, all corruption cases would be probed under Supreme Court supervision. The minister claimed BJP would cross 50% vote share in the 2026 polls. "In 2019 we had 41%, in 2021 we had 38%, in 2024 we got 39%. It is time to go past 45%," he told party workers, saying the change in govt will be a "fitting tribute" to Syama Prasad Mukherjee. On border security, Shah alleged the Bengal govt had not provided land to BSF to build a proposed fence along India-Bangladesh border. Seeking to reassure Matua and Namashudra communities amid EC's SIR exercise, Shah alleged that they were being intimidated.

TMC cites Goa nightclub blaze, Indore deaths to counter Shah

Kolkata: TMC national general secretary Abhishek Banerjee countered Union minister Amit Shah's attack over the Kolkata fire, saying BJP would be held "equally responsible" for other fatal disasters such as the Goa nightclub blaze if Bengal CM Mamata Banerjee is blamed for deaths of 27 people. He said if the CM was held responsible for the deaths, the PM and Shah were responsible for over 140 deaths allegedly linked to SIR and 150 during demonetisation. Pointing to the Goa blaze and deaths in Indore from "contaminated" water, Abhishek asked why accountability stopped at state borders. "When you point one finger at someone, three fingers will point back at you," BJP governors both Goa and MP said.

Modi's decision to rename the airport is part of the government's Dalit outreach, which is Modi's parliamentary constituency, for building his memorial in Sagor in MP and visited Ravidas temples to pay tributes. He has in the past years launched projects for the development of the birthplace of Ravidas, a Bhakti movement post-saint born in Varanasi, which is Modi's parliamentary constituency, for building his memorial in Sagor in MP and visited Ravidas temples to pay tributes. awarded a Padma Shri this Republic Day. The dera is based in Jalandhar, a part of Doaba region where the concentration of SCs is higher than the rest of the state. While Dalits account for nearly 32% of the population in Punjab, there are no other states, they are nearly 42% in Doaba. Though Dalits in Punjab are divided in several sub-groups, Ravidassia community, which comprises 10-12% of the population, is one of the bigger ones and Ravidas is a respected figure among SCs. Reaching out to disadvantaged castes has been a part of BJP's drive, for its agenda of Hindu cohesion and has helped the party's growth. Punjab assembly elections are due in the first quarter of next year.

Kuala Lumpur: Malaysian PM Anwar Ibrahim will be present at the airport, along with Indian High Commissioner to Malaysia, B N Reddy to receive PM Narendra Modi for his brief but packed visit to Malaysia on Feb 7. The visit is being seen as validation of growing ties between the two nations, especially after Anwar's official tour to India in Aug 2024, which led to the upgrade of bilateral relations to Enhanced Strategic Partnership. Malaysia is home to the second largest PIO community after the US, and India recently extended registration for OCI to 6th generation of PIO descendants.
