1.0 Introduction

GAIL's Petrochemical Complex at Pata is situated in Uttar Pradesh (hereinafter referred to as "**Procurer**") and is presently meeting its power requirement through two sources, distribution licensee i.e. M/s Dakshinanchal Vidyut Vitran Nigam Limited (DVVNL) and internal steam based captive generating assets. GAIL, Pata is having power purchase agreement with DVVNL for power supply through 220 kV dedicated incomer feeder line with a contract demand of 58.8 MVA.

2.0 Expression of Interest (EOI)

Expression of Interest is sought from Independent Power Producer or Captive Power Producer or Power Distribution Company or a Power Trading Company (hereinafter referred to as "**Bidder**") for supplying 20 MW of Round The Clock (RTC) power corresponding to 175 million units (MUs) on annual basis for its Petrochemical plant located at Pata under bilateral open access mechanism for a contract period of one (1) year with an extended term option available for further one more year with prior notice of one month under applicable Regulations, Electricity Act & Rules.
