Terms and Conditions :

1	Offers are invited for supply of RLNG on delivered price basis (rounded off to the 4 decimal places) to a particular fertilizer plant on Reasonable Endeavour (RE) Basis, i.e. without Take-or-Pay Charges.
2	Offers can be made for any/all of the above fertilizer plants. However offer shall be submitted for full quantity only for any/all fertilizer plants for the given month and any offer for part quantity for any plant shall be rejected.
3	Duly signed offers shall be submitted strictly in the format prescribed above (Annexure-1, 2 & 3). Conditional Offers and/or in the format other than above shall be summarily rejected.
4	Successful Supplier/s shall enter into a Gas Supply Agreement with the respective plants, providing full breakup of all the levies and tax components considered in the above delivered price.
5	Offers shall be made for Foreign Exchange in US\$ (FE) and INR components separately for each plant inclusive of all components including applicable taxes and duties etc., and shall be evaluated accordingly.
6	Suppliers' Delivered Price should include all the taxes, duties & levies as applicable for each plant (whether payable by supplier or plant to the tax authorities e.g. Entry Tax, Octroi etc.) without considering any set-offs available to respective fertilizer plants.
7	In case supplies of RLNG on delivered basis are envisaged through swapping of gas, the concerned supplier shall make their own assessment/arrangements and offer the delivered prices accordingly in the above format.
8	In case of tie amongst suppliers for any particular plant, volumes shall be distributed proportionately amongst all such suppliers.
9	Offers shall be submitted latest by 15:00 hrs (IST) of 18.03.2019 , only to the email id: fertilizerpooling@gail.co.in . Late offers and/or any other mode of submission of offer or submission of offers to any other email id shall be summarily rejected. Offers shall be opened immediately thereafter.
10	Offers should have validity upto 12:00 hrs (IST) of 01.04.2019 .
11	Successful supplier/s and respective fertilizer plants shall execute all necessary agreements by 31.03.2019 for supplies/transportation.
12	Details of transportation charges of respective pipeline may be obtained from respective gas transporters.
13	The suppliers are free to use Regas terminal and transportation services of any such service provider of their choice.
14	In case L-1 Supplier backs out after opening of the bids, the same supplier shall be debarred from participating in the bids for next one quarter and offer may be given to next supplier in terms of ranking based on the price quoted by them.
15	The successful suppliers shall be required to supply upto 10% additional gas at the quoted rates as per requirement of individual fertilizer plants.
16	In case of any upward/downward change in transportation charges, taxes & duties during the supply period, the same will be pass-through and accordingly the effective delivered price to the fertilizer plants will be changed.
